## **Release and limitation of liability**



Each participant or other individual or entity participating in any aspect of the Tarrant County Sheriff's Posse Trail Ride including without limitations livestock and animal entrants including any of their heirs, dependents, assigns, agents or representatives in any capacity hereby waives all rights and claims for damages and do hereby agree to release, hold harmless, and unconditionally indemnify Tarrant County Sheriff's Posse sponsors and co-producers of Tarrant County Sheriff's Posse Trail Ride and any officials or employees from all liability, cost, expenses, claims and damages even if caused by the alleged negligence of or gross negligence of the Tarrant County Sheriff's Posse. Trail Ride or event participant, may not at any time suffer or sustain or become liable for any reason of accidents, damages, injuries, or incidents either to the person or property, or both or the Tarrant County Sheriff's Posse participant, or of any other parties, in any manner arising from such participants participation in the Tarrant County Sheriff's Posse Trail Ride, or trail ride premises which is in any way connected the Tarrant County Sheriff's Posse Trail Ride, its officers, directors, members, sponsors, agents or employees of the Tarrant County Sheriff's Posse Trail Ride.

Participant also recognizes that it will be solely responsible for any consequential or other loss, injury or damage to, or occasioned by, arising from, any horse or other livestock used by the participant or present at the Tarrant County Sheriff's Posse Trail Ride, including the preparation, duration, and disbanding of said trail ride, and any parts thereof.

Participant further agrees to execute such releases or other writings or other documents which evidence participants acknowledgment and understanding of the foregoing release and indemnity, provided, however, the provisions hereof shall prevail in the event that a conflict or other inconsistency is discovered regarding the contents of this provision and any releases executed by a participant.

**Date and Time:** Saturday October 6th, 2018, 10:00 AM

**Parking:** Parking will be in the Stockyards south parking lot #2 on east side of all the shops off 23rd street.

**Check in:** Check in time will be 8:00 AM and everyone will need to be checked in and ready to assemble and ride out at 10:00 AM.

**Route:** The trail ride will begin from the Stockyards parking lot #2, and follow the path of the Trinity river around to the midway point, Lunch will be served, Door prizes will be drawn during the lunch then the return ride back to parking lot #2

**Rules:** All participants safety is the utmost priority of the trail ride. Riders are expected to use significant caution at all times.

**ABSOLUTLY NO FIREARMS CONCEALED OR OPEN CARRY WILL BE ALLOWED IN THE STAGING AREA OR ON THE TRAIL RIDE. NO EXCEPTIONS**

Horses should be able to cross bridges and obstacles

No alcoholic beverages will be allowed in staging area or the trail ride. No exception.

No double or backward horseback riding, no animals tethered to other animals, no riders on lead lines permitted.

Do not slow or stop forward progress of trail ride. Participants must follow instructions of posse members at all times.

Only saddle or draft horses will be allowed. No studs ALLOWED. Kickers must be RED TAGGED.

Tarrant County Sheriff's Posse reserves the right to deny participation or remove from trail ride any person or animal that may be falsely entered or may be deemed unsuitable or objectionable without assigning reason thereof.
